

UK-based Law Firm meets mission critical RPO and RTO Objectives with Zerto

Overview

One of the fastest growing law firms in the UK, ranked in the top 25 with over 2000 employees, is relying on their robust IT infrastructure and information availability to provide a clear competitive advantage. However, their current snapshot-based replication solution was not able to meet their aggressive recovery point objectives (RPOs) and recovery time objectives (RTOs). They needed very aggressive service levels to minimize data loss which could directly impact their revenues. Any update or research done to a customer case is a billable activity, if that activity is lost, it needs to be redone, increasing costs. With Zerto Virtual Replication, they are seeing RPOs of seconds and RTOs of minutes, laying a strong foundation for their continued growth. Their DR solution ensures information availability to case lawyers and accurate billing for customers, enabling them to continue to deliver exceptional service and legal counsel.

The Problem

At the heart of the law firm is the availability of information. The ability to effectively manage a case, find case law and other relevant documents and ensure the best and most accurate information is available when it is needed. They have 80 virtual machines supporting their most critical applications — case management, Microsoft SQL Server, Elite 3E and others. If any of these applications are not available, there is a loss — revenue, clients, cases and productivity. The previous replication solution, a Backup and Replication solution, was VMware snapshot-based and did not meet the required aggressive RPOs and RTOs. Additionally, the solution would slow the application performance, which made a direct impact on the productivity of the users. The IT team had to change the frequency of the snapshots so they would only execute during off-hours to ensure productivity was not lost — contributing to the deterioration of the SLAs.

Additionally, the law firm needs to protect their IP. Any work that a lawyer does on a case is billable to the customer. To ensure accurate billing, this law firm breaks out each hour into ten, 6 minute segments. They want to be very granular and accurate in terms of the billing. With over 700 lawyers, if they lose even just one 6 minute segment, they will have lost 70 hours of billable time — a significant loss in revenue. With Zerto, and an RPO of seconds, they ensure accurate and complete billing of all lawyer consulting time.

- **Hardware-agnostic:** Zerto Virtual Replication (ZVR) is storage agnostic so it can replicate from any kind of storage to any kind of storage — an older array or different type of storage altogether can be leveraged at the target site.
- **Low network requirements:** ZVR replicates only what is needed — the write I/O from each VM. Also, as the replication is continuous, the write I/O is compressed and moves over the network just as it is created, significantly reducing bandwidth requirements.
- **Simple failover testing:** The testing of the BC/DR process is simple and can be done with one click, giving the customer the peace of mind that the solution will perform as advertised and their information and applications will be protected.
- **Ease of migration:** The ability to pre-seed the replication site provided a simple migration from the current solution to Zerto Virtual Replication.
- **Very high ROI:** The cost of one hour of downtime is £100,000. This more than covered the cost of the product which made the purchase decision very easy.
- **Continuous replication with no performance impact:** The Zerto Virtual Replication Appliance is a very light piece of software that installs on the ESX host, delivering aggressive RPOs. This company was seeing just 10 seconds, with no measurable performance impact on the application.
- **Application consistency and journaling:** The Zerto VSS Agent ensures application consistency across all VMs. The 24 hours of journaling eliminates the need for SQL transaction log backups between the nightly full SQL backups as they can failover to any point in time in the last 24 hours in the event of a data corruption.
- **Great support from the Zerto team:** The user support was more than helpful. No matter when the IT team called for support, the Zerto team was available and able to resolve the issue quickly.
- **Very low RPOs and RTOs:** In order to ensure accurate billing, the customer broke out each hour into ten 6 minute segments.

With over 700 lawyers, if they were to lose this billing data, even for one 6 minute segment, they would not be able to bill for 70 hours of time. With Zerto, and an RPO of seconds, they ensure each segment can be recovered for complete billing of all work for any client.
